Subject: Selection of Haj Trainers for Haj - 2017.

Whereas the Govt. vide No.54 – Rev(H&A) of 2017 Dated:28/02/2017 constituted a committee for selection of Khudam UI Hujaj. Later on the said committee was entrusted the job of conducting interview as well for selection of Haj Trainers.

Whereas Haj committee of India vide No. HCOI-II/64/2017/4466 Dated: 17/02/2017 issued notification to the effect of Selection of Trainers and inviting of applications and selections through respective State Haj Committees.

Consequent upon the above a notification to the effect was issued by this office vide No.Haj/2017/124/120/OT Dated: 13/02/2017 inviting applications from the desiring Govt. Officials/Officers of J&K State.

Whereas, as per the standing norms circulated by the Haj Committee of India the Haj Trainers are to be selected against the ratio of 1:250 pilgrims.

Whereas the said instructions mutatis mutandis entailed that the above referred ratio can be moderated in order to give coverage to all/maximum number of districts.

Whereas after inviting of applications from deserving Govt. Officials/Officers of the state interview was conducted by the Selection Committee on 13/02/2017 and their after merit panels were formulated.

Whereas the Govt. decided to adopt the following order of preferences while making selection of the trainers only to ensure that fresh talent is given a chance to serve as Haj Trainers.

1st Preference	First timer applicants on the basis of merit in interview.
2 nd Preference	Trainers who have attended training only once in respect of those districts were first timer applicants were not available or were lesser than the required numbers of trainers to be selected.
3 rd Preference	Trainers who have attended training more than once in respect of those districts were first timer applicants were not available or were lesser than the required number of trainers to be selected.

Whereas as the Selection Committee decided to waive off the conduct of interview in respect of Jammu Division & Ladakh Region due to the lesser number of applicants & inclement weather on one hand & urgency of submission of select list of Trainers to HCOI on the other.

Whereas upon the basis of the performance of applicants in the interview viz a viz preference charter adopted thereupon the selection list of trainers as drawn is enclosed as Annexure A.
